CURRENT WATER FREEDOM RATES



The freedom water rates payable by you shall consist of 2 elements:

1. All wholesale water costs. This includes all costs levied by the Wholesaler / Undertaker to Yu Energy that relate to the provision of your water, sewerage and trade effluent services to your Supply Point ID (SPID).
2. An amount per SPID as calculated in the table below:

Group	Uplift on Charges (%)	Fixed Charge (£)	Meter Read Cost Allowance (£)
Group 1 Uses up to 0.5Ml of water per annum.	4.45	52.35	10.20
Group 2 Uses between 0.5Ml and 50Ml of water per annum.	8/10 (Depending on water/waste)	N/A	N/A
Group 3 Uses more than 50Ml of water per annum.	8/10 (Depending on water/waste)	N/A	N/A

* As reported in the Central Market Operating System (CMOS) as provided by the Water Market Operator Services Limited (MOSL) the amount in part 2. For the avoidance of doubt, the freedom rate for water is calculated as the amount in part 1 (wholesale water cost) plus the amount in part 2.
